<ul> <li>The Santa Fe Service Unit (SFSU) Executive Committee endorsed the creation of a SFSU Palliative Care Program, directed by Dr. Scott Akin, a staff medical officer who is certified by both the American Board of Family Medicine and the American Board of Hospice and Palliative Medicine. In consultation with CAPT Ballantyne and Drs. Smoker and Thompson, Dr. Akin will coordinate the creation of a core team comprised of clinicians, allied health professionals, and business office staff. The team will participate in a year-long training and mentoring program sponsored by The Center to Advance Palliative Care.</li> <li>The Dental program at the Mescalero Service Unit added an additional operatory to address the oral healthcare needs of the patient population. The three operatories will increase patient access and potentially increase third party revenue.</li> <li>In January, the Albuquerque Service Unit on-boarded a Family Medicine Physician at the Zia Health Center, one of two satellite health facilities of the service unit.</li> <li>Several key appointments were made in the Zuni Service Unit, including a Supervisory Physician (ADM/FP), a Clinical Nurse Supervisor and a Supervisory Occupational Therapist. ## Goal 3: To strengthen IHS program management and operations

- The leadership at the Ute Mountain Ute Health Center continued to collaborate with the Ute Mountain Ute Tribe's Department of Health to streamline payments associated with patient referrals under the federally-administered Purchased/Referred Care program. Federal and tribal staff that have a role in processing specialty healthcare referrals meet regularly to ensure timely payments are made to vendors after patient visits to specialty care facilities.
- The Mescalero Service Unit continued to focus on the outpatient expansion project that is designed to improve patient access and patient flow. Despite experiencing barriers and obstacles, the MSU leadership anticipates MSU will break ground in 2023. This project is critical to the healthcare service delivery system and will dramatically improve and expand healthcare services to the community.
- Leadership from the Albuquerque Service Unit continued to attend workgroup meetings with Innova Group consultants, Area Office leadership, Indian Health Service staff from Headquarters and Tribal leaders regarding replacement and establishment of new healthcare facilities, Albuquerque Central and Albuquerque West, respectively. The workgroup completed Site Selection Evaluations (Phase 1) for the new Albuquerque West facility.
- In the second quarter of FY 2023, the Jicarilla Service Unit exceeded third party revenue projections by 14 percent. The additional resources will support the Service Unit in its overall operations.
