Year 1 Project Narrative Revisions

- During the MSPI/DVPI Kickoff Meeting in Denver, CO, all projects were informed that they were to move forward with Project Narrative revisions for Project Year 1.
- The Division of Grants Management and the Division of Behavioral Health concluded that Project Narrative revisions for Project Year 1 **should not be a current requirement** since projects are currently in a planning phase and well into Project Year 1.

YR1 Project Narrative Revisions: NO LONGER REQUIRED

- **Project Narrative revisions for Project Year 1 are no longer a requirement for submission.**
- Official contacts for all projects were emailed on Monday, February 1st to inform that they were no longer required to submit project narrative revisions for YR1
- Official contacts were also informed in that same email that they **could begin developing their YR2 project narratives.**

Year 2 Project Narrative Development

- **Year 2 Project Narratives** will be one (1) requirement for the **Continuation Application Kit** for all grantees/federal awardees.
- Year 2 Project Narrative development should be the focus of the grantees/federal awardees moving forward.
- More information on the Continuation Application Kits requirements, access, and process will be disseminated to grantees/federal awardees on February 29, 2016 by GrantSolutions (for grantees) and DBH (for federal awardees).

MSPI Purpose, Overall Goals, and Specific Objectives

MSPI Purpose

- The primary purpose of the MSPI is to accomplish 6 overall goals.
- For MSPI Purpose Area #3, you will be addressing overall goals #4 and #5.

MSPI Goal #4

4. Identify and address methamphetamine use among AI/AN populations through the development and implementation of culturally appropriate and community relevant prevention, treatment, and aftercare strategies.

MSPI Goal #5

5. Increase provider and community education on suicide and methamphetamine use by offering appropriate trainings.

MSPI Purpose Areas

- Purpose Area 1: Community and Organizational Needs Assessment and Strategic Planning
- Purpose Area 2: Suicide Prevention, Intervention, and Postvention
- **Purpose Area 3: Methamphetamine Prevention, Treatment, and Aftercare**
- Purpose Area 4: Generation Indigenous Initiative Support

MSPI Purpose Area #3 Objectives

Your MSPI grant/federal award will address **ALL 8** of the following specific objectives for MSPI Purpose Area #3:

1. Expand available behavioral health care treatment services;
2. Foster coalitions and networks to improve care coordination;
3. Educate and train providers in the care of methamphetamine and other substance use disorders;

MSPI Purpose Area #3 Objectives (cont.)

4. Promote community education to prevent the use and spread of methamphetamine;
5. Improve health system organizational practices to improve treatment services for individuals seeking treatment for methamphetamine and other substance use disorders that contribute to suicide;
6. Establish local health system policies to address methamphetamine use and other substance use disorders that contribute to suicide;

MSPI Purpose Area #3 Objectives (cont.)

7. Integrate culturally appropriate treatment services; and
8. Implement trauma informed care services and programs.

Moving Forward with the Development of Year 2 Project Narratives

Development of Year 2 Project Narratives

- Many awarded projects did not address the MSPI Purpose Area specific objectives as required in the grant application for Project Year 1.
- All grantees/federal awardees are required adhere to the Project Narrative requirements listed in the funding opportunity announcement for the Year 2 Project Narratives.
- These TA webinars are scheduled for projects to provide everyone with guidance on the requirements so you are all successful with development of Year 2 Project Narratives.

Development of Year 2 Project Narratives

- Don't Panic!
- You are no longer required to submit revisions to Year 1 Project Narratives.
- You have a **4 months** to begin developing your **Year 2 Project Narratives**.
- IHS will be conducting TA webinars throughout the month of February and the first week of March 2016.

Development of Year 2 Project Narratives

Q: What if I have questions about this process or how to start writing my Year 2 Project Narrative?

- Contact your assigned IHS Area Project Officer who can provide you with technical assistance.

Q: Is it too soon to start working on Year 2 Project Narratives?

- Start the required revisions process now – the sooner you start, the more time you have for questions and to receive guidance.

REMEMBER!

- You will submit your Year 2 Project Narrative revisions as part of your **Continuation Application Kit**.
- They will not be submitted separately.
- More information will be provided regarding the Continuation Application Kits on February 29, 2016.

Year 2 Project Narrative Requirements

Guidance in the
Funding Opportunity announcement (FOA)

Recommendations

Evidence-Based Practices, Practice-Based Evidence, Promising Practices & Local Efforts

- IHS strongly emphasizes the use of data and evidence in policymaking and program development and implementation.
- Awardees for Purpose Area 3 must identify one or more evidence-based practice, practice-based evidence, best or promising practice, and/or local effort that they plan to implement.

Guidance on the Development of Project Narratives in the FOA

- The focus of **Purpose Area #3** is on the prevention, treatment, and aftercare for methamphetamine use (and other addicting substances) among American Indian/Alaska Native populations.
- In addition to prevention programming, MSPI funds can be used to provide behavioral health treatment services (i.e., direct services including in-patient and out-patient treatment, intervention, and aftercare).

Guidance on the Development of Project Narratives in the FOA

- In the “**Application Review Information**” section of the funding opportunity announcement (FOA), please reference “**Section B: Project Narrative/Proposed Approach/Project Plan**” (page 31) for detailed instructions on how to write the Project Narrative.

Recommendations

- When you are ready to begin developing your Year 2 Project Narrative, we recommend that you:
 - **Reference the funding opportunity announcement (FOA) guidance.**

Recommendations

- **Use the MSPI Purpose Area #3 specific objectives:**

1. Expand available behavioral health care treatment services;
2. Foster coalitions and networks to improve care coordination;
3. Educate and train providers in the care of methamphetamine and other substance use disorders;

Recommendations

7. Integrate culturally appropriate treatment services; and
 8. Implement trauma informed care services and programs.
- **Remember that you must address ALL 8 of the objectives for MSPI Purpose Area #3.**

Guidance for Project Narrative Revisions

- Confirm that you are addressing **ALL the required objectives listed for your chosen Purpose Area.**
- Review your current Project Narrative **activities** and make sure they fit with and address the specific objectives.

Recommendations

- Confirm that the Year 2 Project Narrative addresses **ALL the required objectives listed for your chosen Purpose Area.**
- Review all Project Narrative **activities** and make sure they fit with and address the specific objectives.
- Make sure that the Year 2 Project Narrative matches the budget/budget narrative for your project.
 - You will be working on developing a Year 2 budget/budget narrative for the Continuation Application Kit as a requirement.

Local Data Collection Plan

- **REMINDER:** All grantees/federal awardees will work with their TA Provider on their Local Data Collection Plan in Project Year 1 & the beginning of Project Year 2.
- All grantees/federal awardees are expected to finalize the Local Data Collection Plan by **May 2017** for submission to the Division of Behavioral Health.
- Revisions and submission of the Local Data Collection Plan are **not required** at this time.
