1	<b>Review</b> your program’s 2022 SDPI application (Project Narrative – Part F). Note the Best Practice selected and Target Group information.	Your program’s 2022 SDPI application.	
2	<b>Request access</b> to the SOS if you don’t already have it. If you have accessed the SOS previously, but cannot remember your username, contact the SDPI team at <a href="mailto:sdpi@ihs.gov">sdpi@ihs.gov</a> .	<a href="#">SOS webpages</a> <sup>1</sup>	
3	<b>Enter Best Practice and Target Group information</b> into the SOS system using the <i>Best Practice/Target Group Info</i> tool. <b>Tip:</b> Ensure 2022 is selected as the year.	<a href="#">SOS webpages</a> <sup>1</sup>	
4	<b>If Target Group IS KNOWN at Baseline (if not known, go to Step 7):</b> <b>Identify and create a list of your Target Group members locally</b> , using Excel, a paper list, or other process. <b>Tip:</b> Only gender and month and year of birth can be entered into the SOS. You may choose to collect other information that is stored outside of the SOS for local use.	<a href="#">SOS webpages</a> <sup>1</sup>	
5	<b>Enter information for each Target Group member into the SOS</b> using the <i>Enter Individual/Information Entry</i> tool. <ul style="list-style-type: none"> <li>- Click on "Enter Individual" in the left-hand menu.</li> <li>- Click on "Individual Information Entry" on the main page.</li> <li>- Ensure 2022 is selected as the year (click "Go" next to the year).</li> <li>- Enter information for each Target Group member, including their baseline RKM Value.</li> </ul> <b>Tip:</b> Add the SOS Participant Identifier for each member to your local list as you enter their information.	<a href="#">SOS webpages</a> <sup>1</sup>

6	<p><b>Review and submit your RKM result in the SOS</b> (<i>Enter Individual/RKM Data Entry</i> tool) after you have entered baseline information for all members.</p> <ul style="list-style-type: none"> <li>- Click on "Enter Individual" in the left-hand menu.</li> <li>- Click on "Individual RKM Data Entry" on the main page.</li> <li>- Review "RKM CURRENT RESULT" section. If result matches your records and the individual data entered, click on the "Submit" button. If not, update individual information as needed or contact the SDPI team.</li> </ul> <p><b>Tips:</b></p> <ul style="list-style-type: none"> <li>-Ensure 2022 is selected as the year (click "Go" next to the year).</li> <li>-The first RKM result you submit will automatically be marked as baseline.</li> </ul>	<a href="#">SOS webpages</a> <sup>1</sup>	
7	<p><b>If Target Group IS NOT KNOWN at Baseline:</b></p> <p><b>Enter baseline information into the SOS System</b> using the <i>Enter Aggregate Data</i> tool.</p> <ul style="list-style-type: none"> <li>- Source: 2022 Application</li> <li>- Numerator=0</li> <li>- Denominator=Number in your Target Group</li> </ul> <p><b>Tip:</b> Ensure 2022 is selected as the year.</p>	<a href="#">SOS webpages</a> <sup>1</sup>	
8	<p>Run and review your program's 2022 RKM Data Summary Report in the SOS.</p> <p><b>Steps:</b></p> <ul style="list-style-type: none"> <li>- Click on "SOS Grantee Reports" in the left-hand menu.</li> <li>- Ensure 2022 is selected as the year (click "Go" next to the year).</li> <li>- Click on the "RKM Data Summary Report" link under "SDPI OUTCOMES SYSTEM REPORTS MENU".</li> <li>- Review your result(s), with particular attention to: <ul style="list-style-type: none"> <li>o Is the exact same value in there more than once? If so, contact the SDPI team to remove one of the values.</li> <li>o Is the correct value marked as Baseline? If not, contact the SDPI team.</li> <li>o Is your baseline value relatively high (&gt;50%)? If so, contact your <a href="#">Area Diabetes Consultant</a><sup>2</sup> to discuss.</li> </ul> </li> </ul> <p><b>Tip:</b> If this report cannot be found or you have any other problems or questions, contact your <a href="#">Area Diabetes Consultant</a><sup>2</sup> or the SDPI Team at <a href="mailto:sdpi@ihs.gov">sdpi@ihs.gov</a>.</p>	<a href="#">SOS webpages</a> <sup>1</sup> <a href="#">Area Diabetes Consultant</a> <sup>2</sup>
