Pharmaceuticals in the Environment

Presenter: James Laurenson, FDA toxicologist

Description: The FDA Center for Drug Evaluation and Research (CDER) has a proactive and dynamic Environmental Assessment (EA) program that has responded exceptionally to recent increases in scientific data and public interest regarding pharmaceuticals in the environment. While CDER's mandate for drug approval and other actions only requires consideration (as opposed to mitigation) of environmental impacts; CDER has embraced a leadership position as an environmental steward, and is working to identify, develop, and support sustainable opportunities. This presentation will address opportunities such as:

- Pharmaceutical-related pollution prevention (e.g., drug take-back and disposal programs)
- Source reduction (e.g., "green pharma", personalized medicine)
- Environmental compliance (e.g., updated NEPA requirements)
- Outreach and communications (e.g., drug package labeling, publications, websites)
- Research (e.g., tools for predicting pharmaceutical aquatic toxicity)

Mr. Laurenson will also detail how these low-cost environmental stewardship efforts would translate into benefits such as reductions in toxicity to aquatic species (e.g., endocrine disruption) and potential risks to humans from pharmaceuticals approved and marketed in the US.

Lastly, this presentation will highlight CDER's commitment to better understand the risks of pharmaceuticals in the environment, providing a positive example for other regulatory agencies and institutions in the U.S. and internationally.

Striving for Net-Zero Energy Consumption in IHS Staff Quarters

Description: Recently passed laws and EOs require federal agencies to dramatically reduce energy consumption in new buildings, achieving Net-Zero energy consumption by the year 2030. This webinar presents an investigation into the feasibility of achieving net-zero energy consumption in IHS Staff Quarters through the use of on-site photovoltaic renewable energy systems coupled with advanced materials, ground-source heat pumps and solar hot water heaters. Several locations in IHS are included in the investigation and represent multiple climate zones. Energy modeling is compared against the 2009 International Energy Conservation Code baseline and life-cycle cost analysis follows the principles of OMB Circular A-94.
