U.S. Influenza Activity


- Low activity across the U.S.
- Most of the viruses detected have been H3N2 viruses
 - Last season circulating H3N2 viruses were “drifted” from the H3N2 component in the vaccine
 - Global laboratory data indicate that most circulating influenza viruses are similar to the reference vaccine viruses used for developing the 2015-2016 U.S. vaccines.
- No pediatric influenza-associated deaths have been reported



Week Ending October 31, 2015- Week 43




*This map indicates geographic spread and does not measure the severity of influenza activity.

Flu Vaccine Supply

- Influenza vaccine supply:
 - Projected: 171-179 million doses
 - Shipped (as of Oct. 30th): 123.7 million doses
- Some manufacturers have reported shipping delays with certain vaccine formulations
 - On-going delays in FluMist (MedImmune)
 - Full distribution to be completed by end of December
 - Initial Delays in single dose presentations of FluZone (Sanofi Pasteur)

Update on HealthCare Personnel Mandatory Influenza Vaccination Policy

- Special General Memorandum signed Sept. 3rd, 2015
 - Require all healthcare personnel working in an IHS healthcare facility receive an annual influenza vaccine by Oct. 31st.
 - Unvaccinated healthcare personnel with a valid medical exemption must wear a mask while working in an IHS healthcare facility for the duration of the influenza season as defined by the Centers for Disease Control and/or their local health jurisdiction.

HCP Flu Vaccination Policy

- Immediate implementation for non-bargaining unit employees
- Implementation for bargaining unit employees pending outcomes of union bargaining processes
